Purpose of research, methodology, results and implications must be clearly indicated in the abstract. You are required to provide key references also. Abstracts will be blind reviewed and only the papers whose abstracts get approved by the reviewers will be selected for presentation. Authors are requested to adhere to the following formatting criterion:

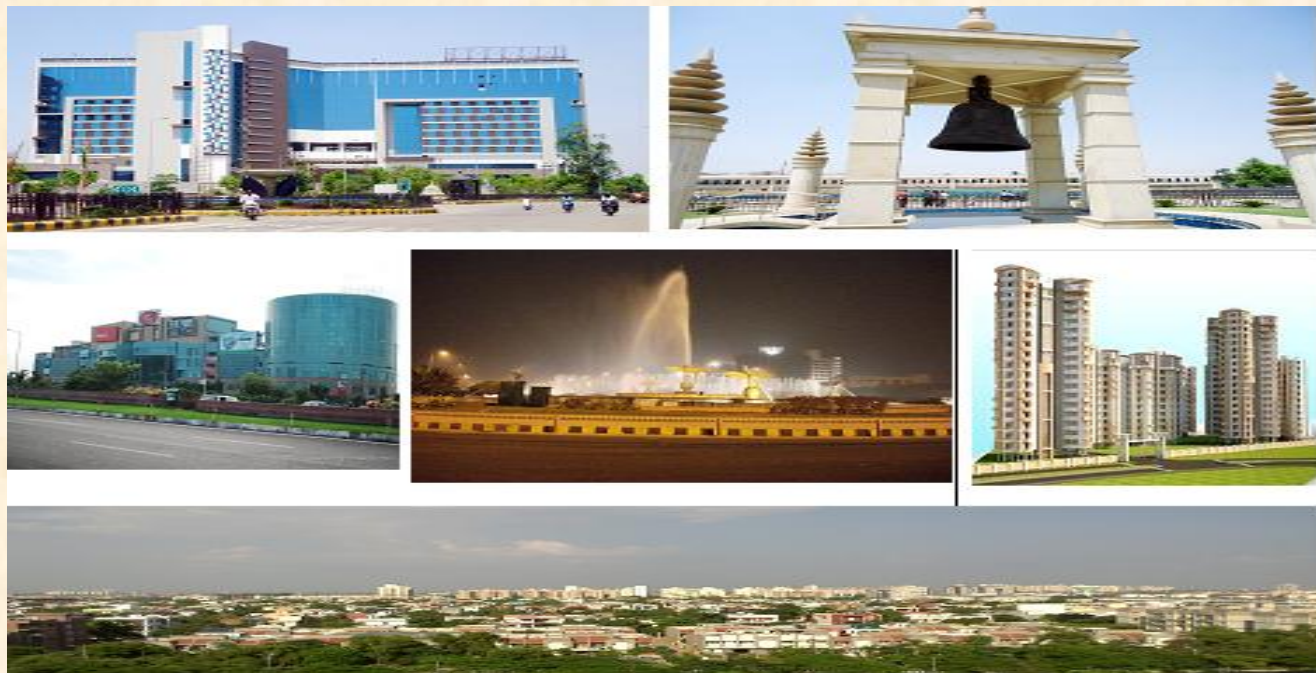

### How to reach Gautam Buddha University, Greater Noida?

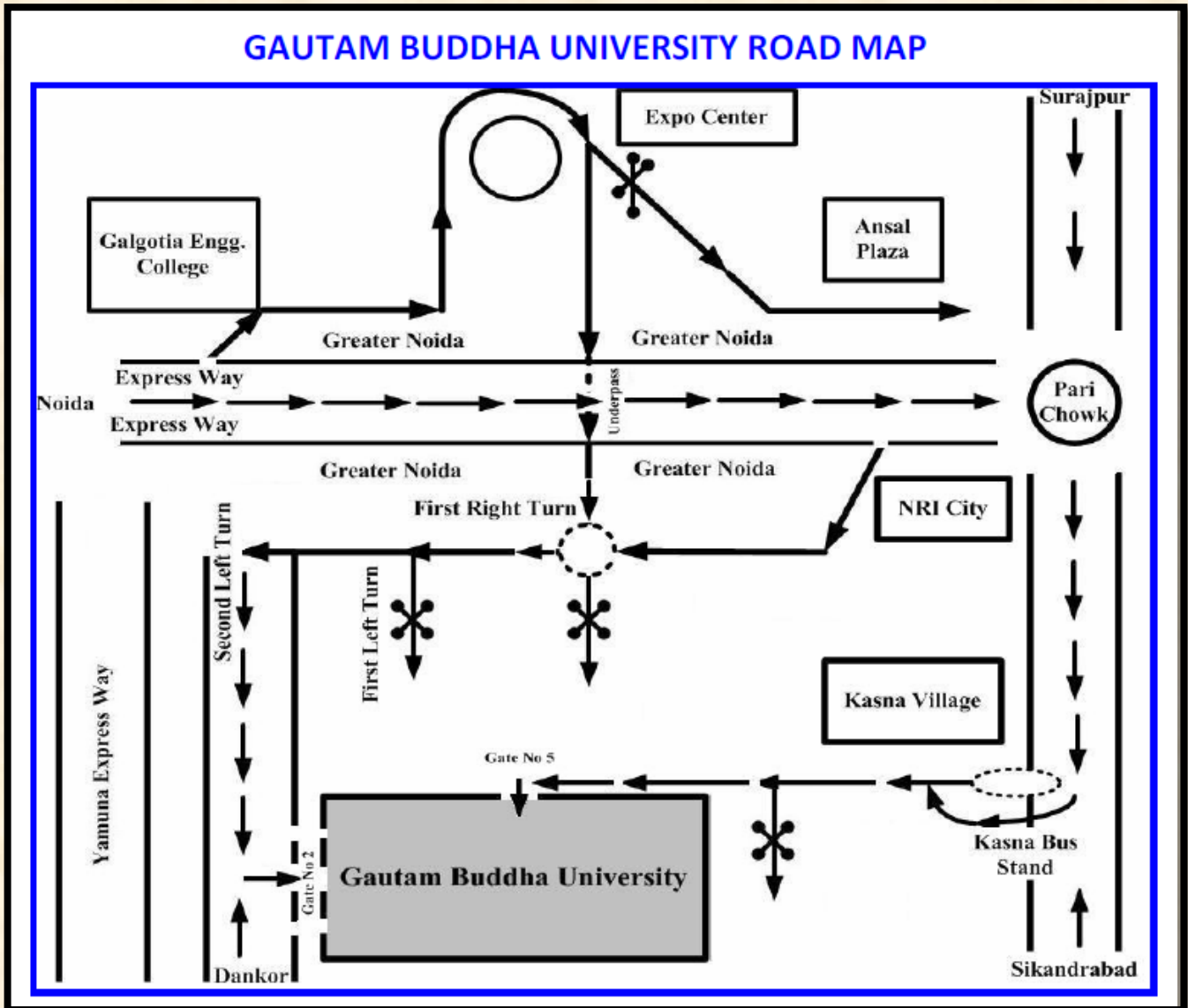

Gautam Buddha University is 55 minutes' drive from the IGI (Indira Gandhi International Airport) and 45 minutes from the New Delhi Railway station. For reaching GBU, on landing in the city ask the taxi/auto rickshaw for "Greater Noida". Taxis are available near the Railway Station as well as the Airport and the tariff varies according to distance.

### Places to Visit

The cities that can be visited during the visit of Greater Noida are Delhi (Places to visit-The Akshardham Temple, The Lotus Temple, The Red Fort, The Qutub Minar, The India Gate among many others ), Agra (Places to visit- The **Taj Mahal** (the medieval wonder) , The Red Fort, The Fatehpur Sikri, Agra is also famous for the 'leather work'), Mathura (The city of temples-Birth place of Lord Krishna-), Jaipur (The pink city of India).
