About the Centre

The Dr. Ambedkar Centre for the Studies of Human Rights has been a unique Centre of Excellence of Gautam Buddha University right from the time of its inception. The Centre of Excellence aims at spreading the gospel and promoting the idea of Human Rights through the prism of Greatest Scholar of all times, Dr. B.R. Ambedkar. How to inculcate into the mind of the students, teachers and citizens with ideas of Human Rights and Human Dignity as perceived by Dr. Amedkar has been the focal area of study of the Centre. By virtue of being human, we all have certain basic rights and liberties which have been bestowed on us naturally. These basic rights and liberties shall have to be entitled to all the citizens of the country irrespective of their caste, colour, creed, community and place of birth. When the Constitution of India was framed, these natural rights and liberties were placed in the Fundamental Rights Section and thus, got guaranteed by the state. Dr. B.R. Ambedkar, struggled relentlessly to bring about changes in social, political, economic, cultural and religious aspects of life of the citizens of the country which were otherwise stagnant and had to live in a strict form of social gradation. But Dr. Ambedkar questioned the status quo and authored the Constitution of India wherein, he included all the basic human rights as fundamental rights under Arts 12 to 35. He not only rescued many illiterates, poor, women, children, weak and marginalized people from the clutches of social stigma, political sabotage, economic handicap, cultural hegemony and religious bigotry but also began a new belief of justice, equality, liberty, fraternity and opportunity for all. The Centre is intended to undertake serious research works on Dr. Amedkar's thought on law, liberty, equality, fraternity, human rights and human dignity. The Centre offers three important Programs of Study on M.A. Ph. D and Certificate Course respectively presently. Students are encouraged to study on Ambedkar Thought, Human Rights, Civil Liberty and Social Justice. The Dr. Ambedkar Centre for the Studies of Human Rights shall endeavor to serve as the Centre of scholarly writings, publications, debates and discussions, seminars, Talks and research works, community engagement and also explore the idea of social engineering in our society.
