

23.10: To apprise the Academic Council about hosting of XI Hutton Symposium on 23. 10 Granites and related rocks at the campus of the GBU during September, 2027



23.12: To apprise and seek approval of the Academic Council for new educational programmes w.e.f. Academic Session 2024-2025

The Academic Council accorded "approval in principle" for new educational programmes in the Academic Session 2024-25, (following the codal necessities), viz., B.Farma, and B.Sc. (Hons.) Forensic Science in the University School of Biotechnology; LLB-03 years programme in the University School of Law, Justice and Governance; Executive Programme MBA in Business Analytics and Data Science in the University School of Management; B.Sc. Environmental Science-04 years Programme as per NEP-2020 and M.Sc., Geology – 02 years Programme in the Department of Environmental Science, USoVSAS; B.Tech. – 04 Years Programme in Mechanical Engineering (with Minor Mechatronics and Automation), and M.Tech. – 03 years Programme as weekend programme for Working Professionals in the Department of Mechanical Engineering, USoE.

Hon'ble Vice Chancellor proposed (i) an inter-school programme – B.Tech. in Mathematics, and Computing under the Department of Applied Mathematics, USoVSAS and Department of CSE, USoICT, and (ii) B.A. and M.A. Programmes in Sanskrit in the University School of Humanities and Social Sciences. The proposals were honoured and accepted by the Academic Council.

23.13: To apprise and seek approval of the Academic Council for the remuneration to faculty members for setting of Examination Papers and evaluation works

The Academic Council took note of it, and approved remuneration to faculty members, both regular and on contract, amounting Rs. 500/- only (Rs. Five hundred only) for setting of examination paper and evaluation works for each course.

The Chairperson – Admissions apprised information about the admissions – related matters of the University. The Academic Council took note of it, and approved the proposals as submitted.


23.15: To apprise and seek approval of the Academic Council for Examination -related matters of the University

Fifty five thousand only) per month w.e.f. Academic Session 2024-2025.

23.17: To apprise the Academic Council about "Implementation of NEP-2020"

23.18: To apprise the Academic Council about the minutes of the Fee Review Committee

The members of Academic Council approved the fee structure as Proposed.

The members of Academic Council were apprised the need of appointing faculty at the level of Professor and Assistant Professor on regular basis as per UGC scale to strengthen and upscale the faculty resources in the University, and also to evolve suitable mechanism for Assistant Professor (On Contract, OC; referred earlier as Research Associate/Faculty Associate on contract RA/FA) to provide them opportunity to appear in interview for selection as regular Assistant Professor in the UGC scale.


It was also submitted to the Academic Council that considering the fast growing strength of the students and existing short-fall in Learners:Teacher ratio, the University School of ICT has placed urgent demand of a minimum of 06 Assistant Professor. Further, in order to fulfil the standards of the regulatory bodies like BCI, AICTE to name a few, there is a necessary requirement of a minimum of 06 Professor in the University Schools.

- 6. External Experts for meeting of Selection Committee (interview) of the faculty position (contract faculty/OCFD) = @ Rs. 4000/- per day All the above will be applicable w.e.f. 01st July, 2023. The Academic Council approved the above recommendations.
