Required Qualifications, eligibility, experience and general instructions:

1. Account Officer:

A Good academic record with Master Degree in Commerce/Economics/ Mathematics with at least 55% Marks or equivalent from a recognized University/Institution.

Desirable: with 03 years working experience of Accounts/Cashier in a University/ Research establishment/ other institution of Higher education the scale of PB -2 GP 4600/-.

Knowledge of working in computerized environment. Mode of Exam./Test : Written Exam / Interview.

Age Limit: 40 Years

2. Assistant Registrar Group-A and Assistant Registrar Group B:

- (i) It is mandatory that the candidates applying for the post of Assistant Registrar Group-A and Assistant Registrar Group-B should be in regular service of the Central Government or State Government on the same post for which they are applying.
- (ii) It is mandatory to send the **No Objection Certificate** issued from the employer along with the application form.
- (iii) Salary and allowances will be determined as per the policy of Uttar Pradesh Government.
