SCOPE OF WORK FOR HVAC AT ANIMAL FACILITY, GBU

Design strategies shall include:

- Uses of 100 % fresh air with no recirculation in Animal holding area
- Managed directional flow
- Positive pressure monitoring and control
- Temperature 22+/- 2 Degree C
- Humidity below 65
- ACPH more than 16
- Supply air with three Stage filtration.
- Exhaust air through HEPA filters

Installation of HVAC systems for the Animal House will also include the following:

- Thermal insulation, GI Ducting for supply & return line
- HEPA filters for Laboratory Exhaust - 2000 CFM
- Supply and exhaust AHUs
- Dx Type Condensing unit - 11 TR
- Electrical wiring for AHU & DX units
- 2 split ACs 1.5 TR
- VFD Control Panel with VFD drive
