## **TERMS & CONDITION OF CONTRACT FOR RUNNING AND MANAGING THE e-RICKSHAWS AT GBU PREMISES FOR A PERIOD OF THREE YEARS**

### **1.0 ELIGIBILITY**

- 1.1 Any person, trust, firm, company or registered co-operative society of Indian Origin may submit proposal.
- 1.2 The person/firm submitting proposal should be competent and ready to enter into contract.
- 1.3 Offer should be submitted in two parts, in two separate envelops; 1) **Technical Bid** and 2) **Financial Bid**. These two envelops shall be sealed in a common cover and addressed/sent to "**The Registrar, Gautam Buddha University, Greater Noida, Gautam Budh Nagar -201312 (U.P.)**" super scribing "**Name of work : CONTRACT FOR RUNNING AND MANAGING THE e-RICKSHAWS AT GBU PREMISES FOR A PERIOD OF THREE YEARS**" so as to reach us on or before last day of submission.
- 1.4 A copy of PAN, GST/IGST registration certificate.
- 1.5 The vendor shall submit an affidavit (duly notarized) on Rs.10/- stamp paper as per below format only (***the affidavit issues date/notarize date should not be earlier than the tender advertisement date***):  
*"I/We hereby confirm and declare that M/s. ..... proprietor/partner(s) is/are not blacklisted/de-registered/debarred by any Government department/Public Sector Undertaking, Universities, Institution and College or any other repute organization for which we have executed/undertaken the works/services during the last four financial years*

### **2.0 HOW TO APPLY**

The applicant may use the Bid Application form of this document.

### **3.0 ACCEPTANCE OF PROPOSAL**

The Competent Authority of the University may without assigning any reason, withdraw all offer at any stage.  
The committee/authorized official is responsible for finalization of the order may accept or reject any offer including the best proposal after considering all other aspects. A proposal cannot be withdrawn once made.

### **23.0 LIABILITY TO PAY TAXES**

All Government taxes due to the Commercial work or activity is to be borne by the allottee.

## 25.0 **OTHER CLAUSES**

- 25.1 The bids will be opened on scheduled date and time in the presence of the bidders/authorized representatives of bidders. Bidders intending to attend the EOI opening should intimate in advance.
- 25.2 The bidders will not be allowed to withdraw their bids and if they do so their earnest money will be forfeited.
- 25.3 The EMD of the successful bidder will be refunded after getting the “Security Deposit i.e. 3% of the total contract value”. The Security Deposit shall be deposited in the form of Demand Draft/Pay Order/FDR only, pledged in favour of “Gautam Buddha University” and payable at Delhi/Noida/Gr. Noida within seven days from the date of acceptance of the EOI. The EMD of the unsuccessful bidders will be returned to the firm(s) immediately after finalization of the EOI. No interest will be paid on EMD in any case.
- 25.4 Offered prices should be valid for at least 180 days from the last date of receipt of tenders.
- 25.5 The GBU reserves the right to award job between the multiple bidders based on the L-1 firm
- 25.6 Subletting of the contract is not allowed in any case.
- 25.7 Initially the contractor shall start, run and manage the 10 e-rickshaws. The quantity may be increased with the written permission from the Competent Authority.
- 25.8 The contractor shall collect the annual fare from the agreed student directly and create a mechanism for the smooth ridding facility to the students.
- 25.9 The University administration will provide the route with the start and end timing to the contractor and the same shall be bound to the contractor.
- 25.10 The University will provide the sufficient charging points to the contractor and the applicable electricity charges shall be borne by the contractor.
- 25.11 The contract will generally be valid for three years which can be extended on mutual consent to a period as decided by the competent authority of GBU. However, the Contract holder reserves the right to accept or not to accept the extension.
- 25.12 There will be no upward change in the price structure during the initial contract period except when statutory levies are made applicable by Govt through notifications/regulations. However, if there happens to be a downward revision in prices during the contract period, the benefit of the price reduction shall be passed on to the beneficiary by the contract holder. The University reserves the right to renegotiate the price with the contract holder.
- 25.13 The Competent Authority of the University reserves the right to make such additions/alteration or modification in terms and condition of the work as necessary from time to time.
- 25.14 All legal proceedings, if necessity arises to the University may be any of the parties (University or Contractor/Supplier) shall have to be lodged in the courts situated at Distt. Gautam Budh Nagar and not elsewhere.
